Authors/Presenters: Academic scholars or practical professionals in IP areas, as well as graduate students, with guidance from their teachers.

Submission Guidelines:

1. Papers may be written in Chinese or English.
2. All submissions should be original, not previously published or under consideration elsewhere.
3. All submissions will be subjected to an anonymous review.
4. The abstract should be between 2,000 and 3,000 words, including issues, analyses, suggestions, and keywords, and submitted as an MS Word document. Submissions should be in Chinese (A4 paper, font 12, Kaiu.ttf(標楷體)), or English (A4 paper, font 12, Times New Roman). Please include the following details in your emails for authors and each co-author (if any):
 -  Full name
 -  Honorific (Dr., Prof, Mr., Ms., etc)
 -  Position title
 -  Institution
 -  Address
 -  Phone number (daytime and mobile)
 -  Email
5. Please upload the abstract by **Friday, June 30, 2023.**
6. The full paper should be submitted by **September 12, 2023** (no longer than 30,000 words) with the title, abstract, keywords (in both Chinese and English), and references.

Important Deadlines:

1. Submission of the abstract: June 30, 2023.
2. Notification of paper acceptance: July 31, 2023.
3. Submission of the entire paper: September 12, 2023.
4. Submission of the PowerPoint slides: September 19, 2023.
